

### APPLICATION FOR MEMBERSHIP

Thank you for your interest in Dana West Yacht Club.

Please complete the attached application and return it to the Club. We will give it prompt attention.

#### Fees at DWYC are as follows:

Initiation fee: \$800.00

• One-time, non-refundable

#### Annual Dues:

**Regular Member** (boat owner or non-boat owner\*): \$1,200.00 / year **Associate (or) Racing Member** (under 35): \$600.00

- Memberships run July 1 June 30, prorated at time of member approval
- May be paid in full or monthly (monthly with automatic debit to credit card only)
  - \$100/month + \$4 processing for Regular Membership
  - o \$50/month + \$4 processing for Associate and Racing Memberships
- Billed in the first January of membership for previous year
- There are NO food or bar minimums at DWYC

## The application process is as follows:

- Complete and submit the Membership Application with your initiation fee (your initiation fee will not be deposited until your application is posted).
- At the next Board meeting, which occurs on the 3<sup>rd</sup> Tuesday of the month, your application will be brought up for posting. It is posted for 30 days.
- Within one week after your application has been posted, you will receive a DWYC Boarding Pass in the mail, which will allow you to temporarily use the club until your Membership is approved.
- At the subsequent board meeting, the Board votes on your application. At that point, your membership will be **approved or disapproved**.
- Fig. IF APPROVED and UPON RECEIPT OF YOUR ANNUAL DUES, your membership will become official.
- Once your membership is official, please contact the DWYC office (949) 661-1185) to arrange receipt of your membership packet, which will include your membership cards. You arrange to may pick up your packet at the club, or it may be mailed.
- The whole process will take approximately 30-60 days, depending on when your application is submitted.
